Policy Statement:

The purpose of the Fire Emergency Response Policy (FERP) is to protect the assets of the Texas Tech University Health Sciences Center El Paso (TTUHSC EL PASO), and to ensure the orderly and efficient transition from normal to emergency operations and back. This is accomplished by the creation of an in-house program to assess the risk of potential emergencies on the institution, and to develop and implement strategies for controlling those risks.

Review:

This Policy will be reviewed every two (2) years by the Sr. Director of Safety Services, with recommendations and revisions forward through the Managing Director of Physical Plant and Support Services to the Chief Operating Officer Vice President for Operations.

Scope and Distribution:

All TTUHSC EL PASO Personnel

Procedure:

Program implementation is the joint responsibility of the TTUHSC EL PASO Facilities Maintenance and Operations (FOM), Texas Tech Police Department (TTP), and TTUHSC EL PASO Safety Services.

Primary risk: is the faculty, staff, students and general public that are within the buildings daily that could be affected in the event of a fire or fire emergency.

Secondary risk: is for the buildings themselves. The majority of the buildings at the TTUHSC EL PASO Campus are equipped with automatic fire sprinkler systems and fire alarm systems. The fire alarm systems have the capabilities for automatic and manual evacuation for each building affected. The fire department is notified from the Central Control Center.

Fire Prevention: is a foundation for all facilities included within this plan. Annual inspections of the life safety systems are conducted annually by licensed outside contractors; i.e., fire suppression systems, elevators, and smoke detectors. In addition, FOM conducts monthly and quarterly Preventative Maintenance (PM) service on these items. Walkthroughs are done continually by individual's doing routine daily work from the Safety Services Department, and inspections are done throughout the year from the TTUHSC El Paso Fire Marshal.

Fire Drills: are conducted yearly for all TTUHSC EL PASO buildings. This is done under the direction of the TTUHSC El Paso Fire Marshal with the cooperation from TTUHSC EL PASO Safety Services, TTUHSC EL PASO FOM and TT Police Department.

The objective of this plan is to provide a reasonable degree of safety by reducing the probability of injury and / or death from the effects of fire & explosion, with due consideration of functional requirements. This is accomplished by:

- Fire prevention and fire response education, which include:
 - Rescue, Alarm, Contain, and Evacuate. (R.A.C.E.) procedures
 - Hands-on fire extinguisher training
 - Fire drills
 - Incident reporting procedures
 - Pre-fire planning with the local fire department
- Prevention of ignition
- Early detection of smoke and / or fire
- Building evacuation
- Control of fire development
- Confinement of the effects of fire
- Extinguishment of the fire
- Investigation of all fire related incidents

Response:

The Emergency Response Structure:

- TTUHSC EL PASO FOM Essential Personnel
- TTUHSC EL PASO Police / Guards
- TTUHSC EL PASO Safety Services (SS)
- TTUHSC EL PASO FOM

The Emergency Response Procedures:

- 24-7 personnel get the call and they will respond to investigate the call.

- FOM Personnel assist in locating announced indicator.
- TT Police will respond and will start to secure the area.
- SS Personnel will assist as need; assist with employee evacuating, assist in providing information to fire department if incident relates to chemicals.
- FOM Personnel will activate and will respond to their assigned locations. They will ensure that people evacuate the building and they go to their assigned assembly locations.

The Emergency Response Resources:

- Building Fire Suppression Systems
- Building Fire Alarm System
- Fire Extinguishers
- City of El Paso Fire Department
- Facilities Essential Personnel (see attachment A)
- TT Police / Guards
- Emergency Call Tree (see attachment B)

Mutual Aid:

It is assumed within this document that the El Paso Fire Department will be notified and respond to fire emergencies. Once on the scene the El Paso Fire Department will be in command of the event until it is mitigated.
