Policy Statement

Texas Tech University Health Sciences Center El Paso (TTUHSC El Paso) recognizes that individual rights are a critical aspect of maintaining quality care and service and is committed to allowing individuals to exercise rights under the HIPAA Privacy Rule, and other applicable federal state and/or local laws and regulations. To support this commitment, TTUHSC El Paso will maintain and update, as appropriate, written policies and procedures to provide guidance on employee and organizational responsibilities regarding using, disclosing or requesting PHI to make reasonable efforts to limit PHI to the minimum necessary to accomplish the intended purpose of the use, disclosure or request.

Scope

This policy applies to all health care clinical service areas owned and/or operated by TTUHSC El Paso

Definitions

Policy

When using or disclosing PHI or when requesting PHI from another covered entity, TTUHSC El Paso will make reasonable efforts to limit PHI to the minimum necessary to accomplish the intended purpose of the use, disclosure or request.

At TTUHSC El Paso, disclosure of PHI to the workforce shall be limited based on the workforce member's need to access PHI as required to perform their duties and responsibilities at TTUHSC El Paso.

The minimum necessary standard does NOT apply to the following:

1. Disclosures to or requests by a health care provider for treatment purposes;
2. Uses or disclosures made to the individual for treatment, payment or health care operations or as properly requested by the individual;
3. Uses or disclosures made pursuant to an individual's Authorization;
4. Disclosures made to the Department of Health and Human Services when disclosure of information is required under the privacy rule for enforcement purposes;
5. Uses or disclosures required by law or for compliance with other policies herein.
