**Objectives:** Upon completion of this session, participants should be able to:

1. Recognize the variety of *instructional* opportunities for the delivery of educational programs in the era of COVID, and post-COVID.
2. Distinguish the different challenges for creating *community* in the remote classroom.
3. Compare the changing needs for *assessment* with the pedagogical shifts since moving from F2F to remote learning.
