Objectives: Upon completion of this session, participants should be able to:

1. Recognize the main functionality of our new curriculum management system, Elentra, for the Foster School of Medicine and Hunt School of Dental Medicine (going live 2021).
2. Differentiate between Canvas, a learning management system (LMS), and Elentra, a curriculum management system with some LMS features.
3. Participate in a panel discussion with key stakeholders regarding the implementation plan and related issues.
